SAMPLE ABSTRACT SUBMISSION

Please use the example abstract provided on the following page as a template for your abstract submission. All abstracts must be emailed to congress@childrenandscreens.org as a PDF.

Guidelines:

- Submissions must present sufficient data—coded and analyzed, even if not yet complete—to provide a basis for reviewer evaluation. Full data analysis should be completed before the conference to include the results and conclusion in the presentation.
- Abstracts should not include any graphics, tables, or figures.
- Formatting guidelines:
 - Title should be typed out in standard title case (capitalize major words and words of more than 4 letters, while leaving minor words lowercase).
 - All authors should be listed out with first and last names, with the presenting author underlined.
 - Affiliations should be listed below the authors, using footnotes.
 - Abstract body text should be written in paragraph form according to the following sections, and should not exceed 450 words (not including section headers).
 - Background (including research question and hypothesis)
 - Methods
 - Results
 - Implications (optional)
 - Reference citations may be included in standard parenthetical form (last name, year). Do not include a reference list.
- Please be sure to indicate, below your abstract text:
 - Any funding or other conflicts of interest, including but not limited to, current employment, consulting fees, financial contributions or gifts, and any affiliated products or services that could produce a conflict.
 - A conflict of interest will *not* necessarily preclude acceptance.
 - Your preference for possible presenting roles. It is possible to indicate a general interest in all presenting roles.

Background: The background section should include goals/purpose, research question(s), and hypotheses for the submitted work. Citations may be included (standard parenthetical: last name, year) but are not required, and do count within the word limit. Do not include a reference list. All sections should be written in standard paragraph form and body text (not including headers) should not exceed 450 words.

Methods: The methods section should include appropriate descriptions of the research design, method, and measures of the research. All sections should be written in standard paragraph form and body text (not including headers) should not exceed 450 words.

Results: The results section should clearly describe conducted analyses, including pertinent statistical tests with the value of test statistics. All sections should be written in standard paragraph form and body text (not including headers) should not exceed 450 words.

Implications (optional): The implications section is optional. If included, it should summarize the study's conclusions and impact. All sections should be written in standard paragraph form and body text (not including headers) should not exceed 450 words.

COI Disclosure: *Please include a summary of your funding sources, as disclosed in the COI form submitted to Children and Screens. It is required that disclosures be made for the presenting author, but encouraged to include disclosures for all authors. (This section does not count in the word count maximum.)*

Presenting Role Preference: *Poster and Flash Talk, Poster (This section does not count in the word count maximum.)*
